ADMINISTRATIVE

Mayor Winifred H. Murphy called the meeting to order at 6:30 pm and welcomed everyone in attendance. Town Clerk, Pamela Cashwell, was present serving as clerk recording notes for the minutes.

QUORUM

CLOSED SESSION

social media and the town's website, seconded by Commissioner Lee Carberry and carried unanimously.


Mayor Pro Tem Ralph Smith made a motion to bond the employee on first day of business, seconded by Commissioner Lee Carberry and carried unanimously.


ADJOURNMENT
